#### **REGULAR MEETING**

#### 1. OPENING ITEMS

- 1.01 Mrs. Collins, Board President, called the regular meeting to order at 7:03 p.m. All five board members were present.
- 1.02 Mrs. Collins led in the pledge of allegiance.
- 1.03 There were no patron comments.
