

The iPad is a district owned piece of hardware. You are renting the iPad each year. Your iPad is connected to a mobile device management system. At any time, we can remove or add apps or look at your iPad if the administration deems it necessary.

- I will be responsible for my iPad and any intentional damage
- I will not share my iPad or any of my passwords
- I will not deface or vandalize the iPad, add any stickers or marks on the iPad
- I will only identify my iPad case with materials I can easily remove before returning
- I will not add, remove, or modify any apps or configurations (example: VPN's)
- I will stay on the network filter and not access any inappropriate internet sites or add inappropriate apps and I will not download inappropriate music or materials, or I may face disciplinary action
- I will bring my iPad to school each day fully charged
- I will immediately report my iPad to the police and notify school administration if it has been stolen
- I will immediately notify administration if I have misplaced my iPad
- I will always keep my iPad in its case
- I agree to be solely responsible for keeping the district iPad in good repair and return it in good condition to the school. If the iPad is not turned in at the end of the school year, I will be responsible for the full cost of the iPad
- I am responsible for backing all my data to iCloud or Google Drive
- I am responsible for my iPad charger and will replace it if it's lost, stolen, or broken
